Mission Statement

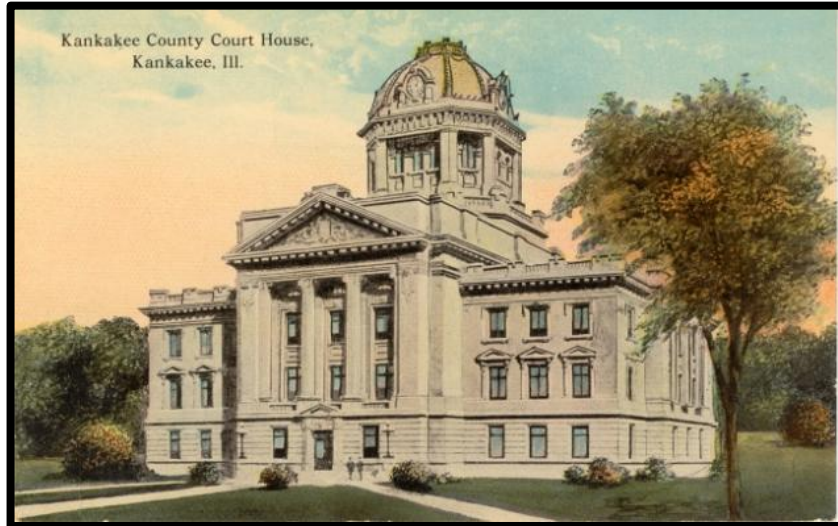

History of the Coroner

In 12th century England, the power of the Sheriff was a growing entity within the King's land. To monitor the Sheriff for evidence of dishonesty, the King created the role of coroner. For each county, four men were selected by the court for the role of "coroner," named so because they were meant to serve the "crown." These men brought important concerns to the attention of the King and investigated any failure to inform the King of these important matters. The coroners were deemed the only persons within the county with the power to arrest the Sheriff himself.

By the 16th century, the coroner had become an elected official. While he still maintained the power to ensure the honesty of public officials, the most prominent role of the coroner had become what it is in the United States today: investigating violent and suspicious deaths.

Role of the Coroner

The Coroner's Creed establishes questions that must be answered to fulfill the requirements of these investigations, as well as provide care and justice for the deceased and for the family and friends of the deceased. These questions are: who, how, where, when, and why?

WHO IS THE DECEASED?

This can be answered by looking at identification found on the deceased or through verification by family members or friends. When identification of an individual is unable to be determined, DNA can be tested to determine identity. Dental records can also be compared to the deceased when possible.

HOW DID THE DECEASED DIE?

This question can be answered by determining the circumstances of death. This is different than why a person died in that it does not provide the medical explanation for death. For example, an accident may be **how** a person died, but head trauma would explain the reason why death occurred.

WHERE WAS THE DECEASED FOUND?

This question can be answered by the person who found the deceased or by officers called to the scene. It is important to know the location and position of the body as well as the condition of the surrounding area.

WHERE DID THE DECEASED DIE?

While the answer to this question will typically be the same as the answer to the above question, a difference will exist in cases where the deceased has been moved. It is important to know the location of death in order to look for evidence of how, why, or when death occurred.

WHEN DID DEATH OCCUR?

This can be answered by determining when the deceased was last seen and how much time has passed since that time. This provides a frame within which death must have occurred. Determining the actual time of death, however, is very difficult to do. As a result, while an approximate time of death can be determined by asking the previous questions, the time of death as recorded by the Coroner's Office is the time at which death is confirmed upon responding to a call.

WHY DID THE DECEASED DIE?

This question asks why a person died in a given situation. As explained in the question of how above, the answer to why a person died will be the particular medical reason for death. In an accident, for example, head trauma would explain the reason why death occurred. In other words, the question of why can be answered by determining the particular cause of death. Determining the medical history of the deceased can also provide insight into why a person died. It is also important to know what medications were in the possession of the deceased at the time of death. Why a person died can ultimately be determined through autopsy and toxicology tests. It is possible, however, that why a person died cannot be determined by autopsy or toxicology results.

WHAT IS THE MANNER OF DEATH?

While the Coroner's Office does not investigate legal matters concerning death, the manner of death may be apparent through determining why a person has died. Based on autopsy or toxicology findings, it may be determined that a person died by homicide, suicide, accidental death, natural death, or an undetermined manner of death.

Coroner Robert J. Gessner



Robert J. Gessner was born in Kankakee, Illinois and lived in the Kankakee area for most of his childhood until his family briefly moved to Michigan. Upon graduating from high school in Michigan, Gessner moved back to his hometown where he worked in his father's factory. In 1969, Gessner began his career with the Kankakee Fire Department. He served the citizens of the City of Kankakee proudly for 30 years until his retirement in 1999. During his tenure with the Kankakee Fire Department, Gessner delivered over a dozen newborn babies, taught hundreds of paramedic students, mentored new fireman and provided a warm loving home for his family.

While employed by the City of Kankakee, Gessner also started working part-time for the Kankakee County Coroner's Office in 1984. Gessner held the title of Deputy Coroner until 1999 when he was appointed Chief Deputy Coroner under former Coroner Dr. James Kelly. When Coroner Dr. Kelly retired in 2003, Gessner was appointed by the Kankakee County Board to serve as Kankakee County Coroner. He was first elected to the position in 2004 and has been successfully re-elected in 2008, 2012, 2016, and 2020.

Coroner Gessner is a member of the Cook County Disaster Team, the Illinois Coroner's and Medical Examiner's Association where he has served as the Secretary since 2003, the Illinois Department of Public Health Maternal Mortality Review Board, the Eastern Illinois Law Enforcement Administrator's Association, the Illinois Department of Homeland Security Board, the Kankakee Chapter of the NAACP, the Duane Dean Board of Directors, the Kankakee Country Club and the Kankakee YMCA Board of Directors. In 2018, Gessner was selected by The Daily Journal as the 2017 Citizen of the Year.



Chief Deputy Coroner Eric L. Cavender



Eric Cavender joined the Kankakee County Coroner's Office in December of 2008. In June of 2014, Eric was appointed as the Chief Deputy Coroner. Eric is a 2008 graduate of Momence High School. In addition, Eric has earned a Master of Science degree in Management and Leadership from Western Governors University, a Bachelor of Science degree in Criminal Justice from Olivet Nazarene University, an Associate of Science degree in Mortuary Science and Funeral Service from Carl Sandburg College, and an Associate of Arts degree from Kankakee Community College.

Eric has completed the basic and master level Medicolegal Death Investigator Training Course through the St. Louis University School of Medicine. He is a licensed Funeral Director and Embalmer in the State of Illinois. He has completed the National Board Exam of Funeral Service Arts and Science, 40-Hour Firearm Training Certification, Lead Homicide Investigator Certification, Practical Homicide Investigation Certification, Command and General Staff Training, FEMA Professional Development Series Certification, FEMA Incident Management System Levels 100 through 800 Certification, FEMA Special Events Contingency Planning for Public Safety Certification and FEMA EEO Supervisor Training Certification.

Eric is a member of the International City/County Management Association (ICMA), the Society for Human Resource Management, the Cook County Disaster Response Team, the Illinois Coroners and Medical Examiners Association, the Hundred Club of Kankakee County, the Eastern Illinois Law Enforcement Administrators Association where he serves as the Secretary, St. George Catholic Church, the Kankakee County Republican Central Committee where he serves as the Treasurer and is on the Board of Directors for Good Shepherd Manor in Momence, Illinois. In addition, Eric is an adjunct professor at Olivet Nazarene University where he teaches in the Social Work and Criminal Justice Program. Eric is married and lives in Bourbonnais.



Deputy Coroner Mark A. Posing



Mark Posing began his career as a local firefighter in 1984. During his time as a firefighter, he was certified as a fire service and EMS instructor for the State of Illinois. He was also trained in hazardous materials operations and technical rescue. Mark worked full-time for the Naperville Fire Department for 23 years. In total, Mark has over 32 years of fire service experience.

In April of 2004, Mark joined the Coroner's Office as a part-time Deputy Coroner, bringing with him his extensive medical and fire knowledge. After retiring from the Naperville Fire Department in 2017, Mark was hired full-time with the Coroner's Office.

Deputy Coroner William J. Perkins

Deputy Perkins has attended basic medical legal death investigation course, lead homicide investigation, and is a certified fire investigator. Deputy Coroner Guy L. Maisonneuve

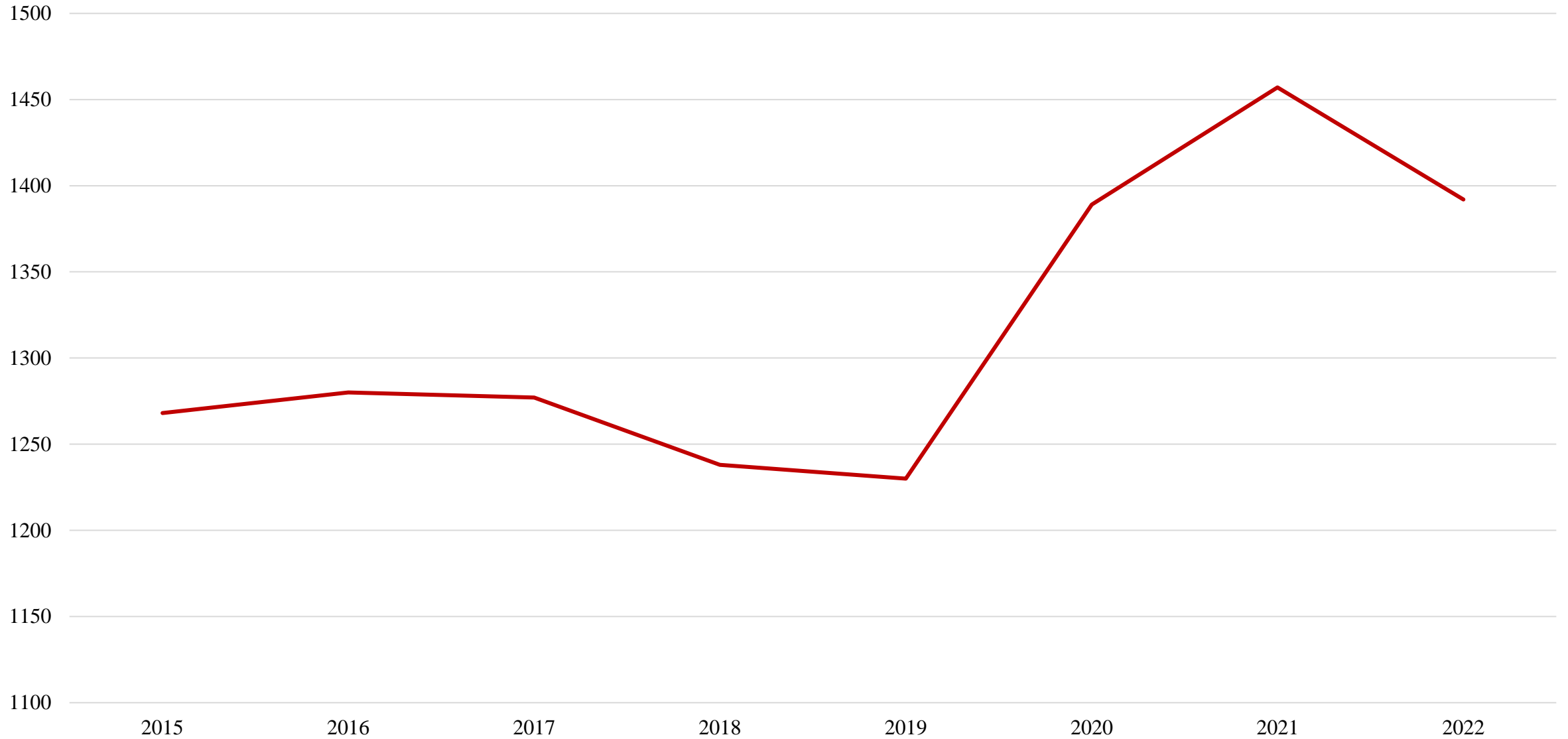
2022 Highlight



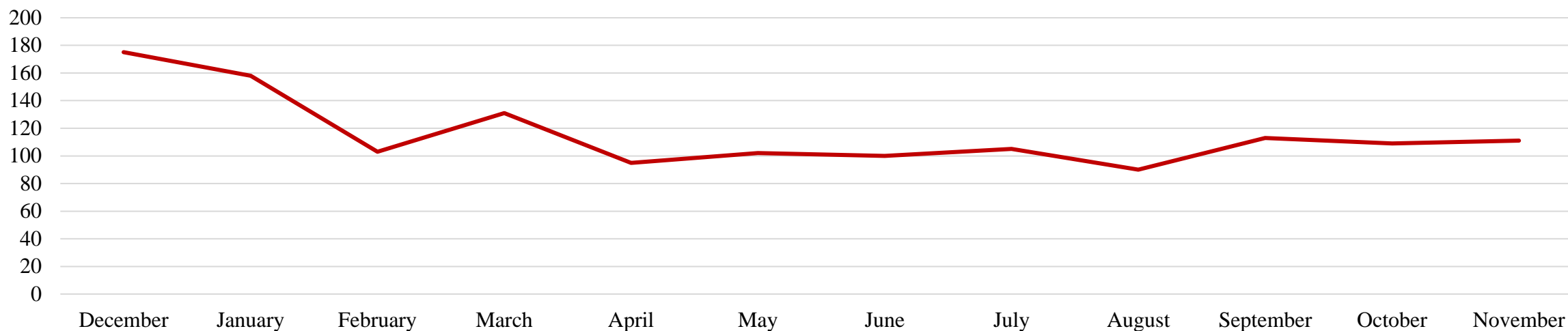
A new walk-in freezer was installed in March of 2022. The new freezer replaces a two-person tray freezer installed in 2005 when the morgue complex was constructed. With this upgrade, our freezer capacity has increased to eight and in total the morgue now has a maximum capacity of 20. Special thank you to the Kankakee County Board for funding this critical infrastructure project with funds from the American Rescue Plan Act. 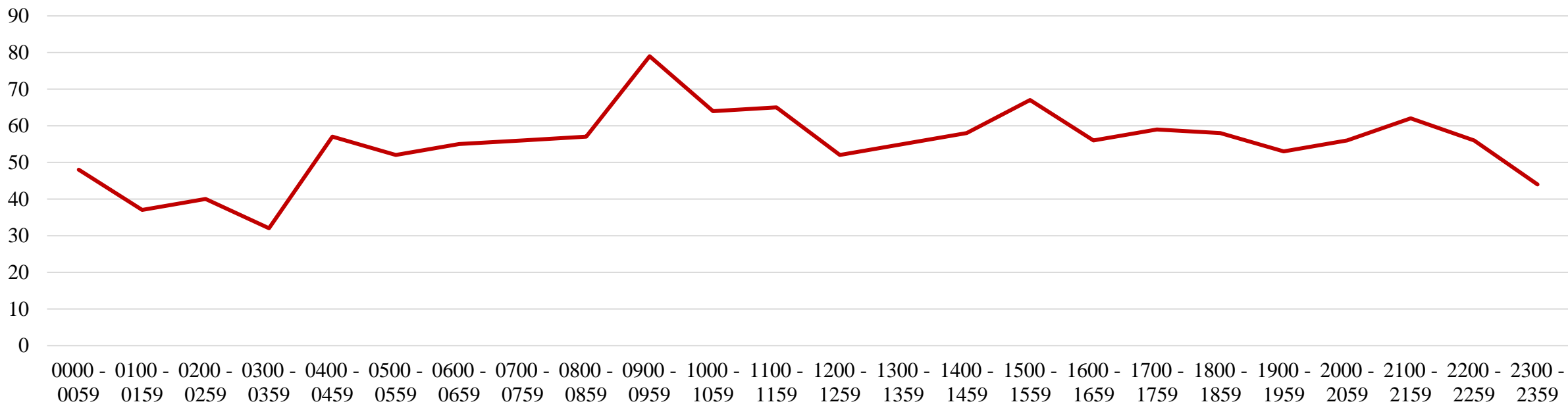

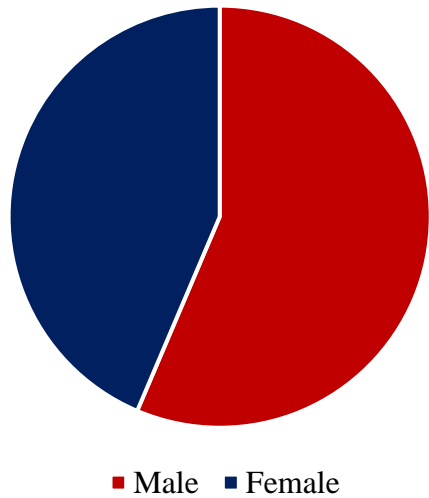
Deaths by Month



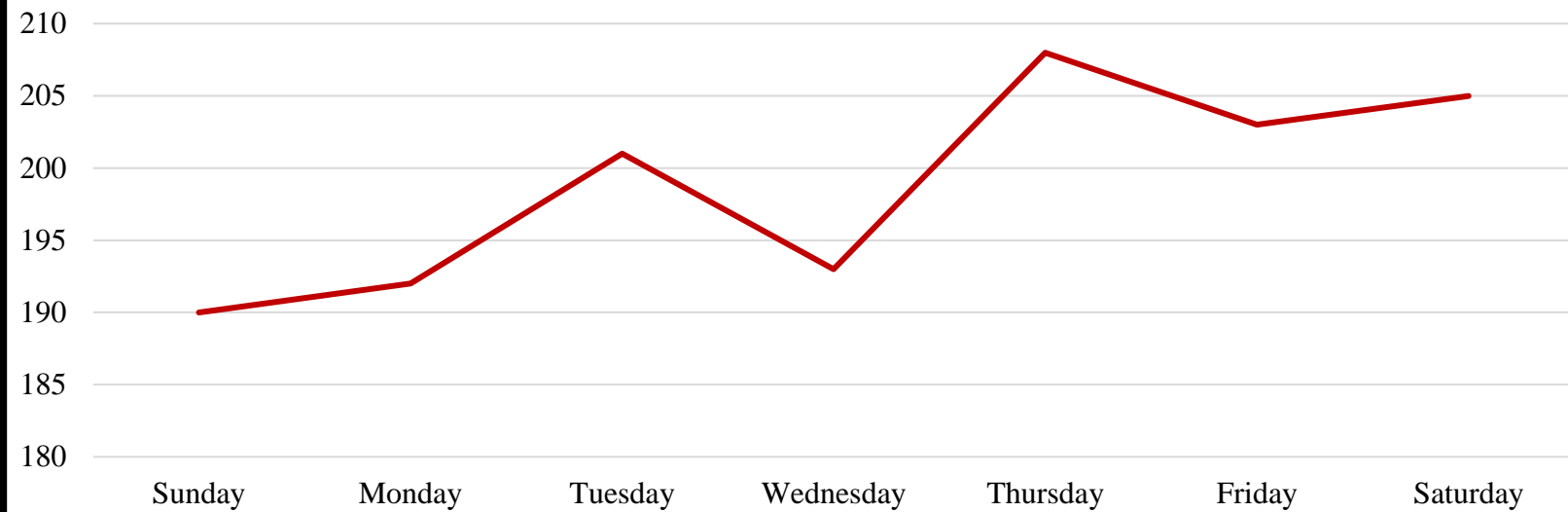
2022 Time of Calls



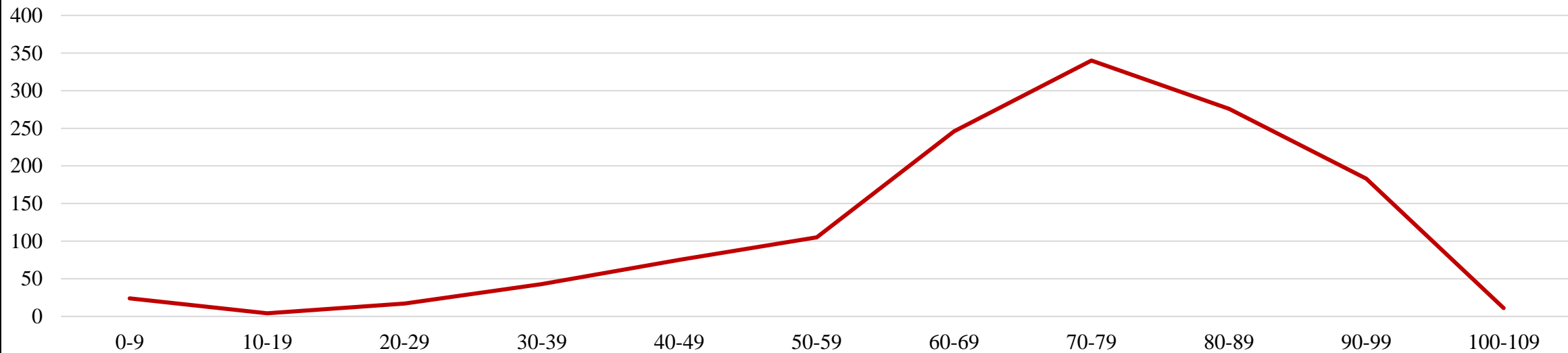
2022 Deaths by Gender



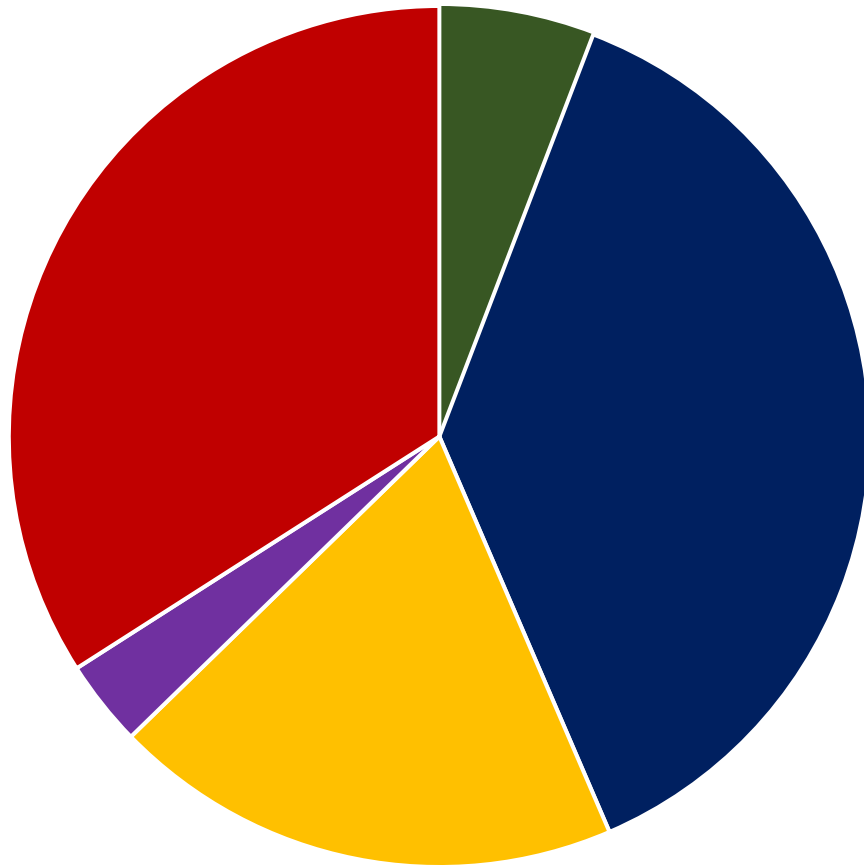
2022 Calls by Day of Week



2022 Deaths by Age

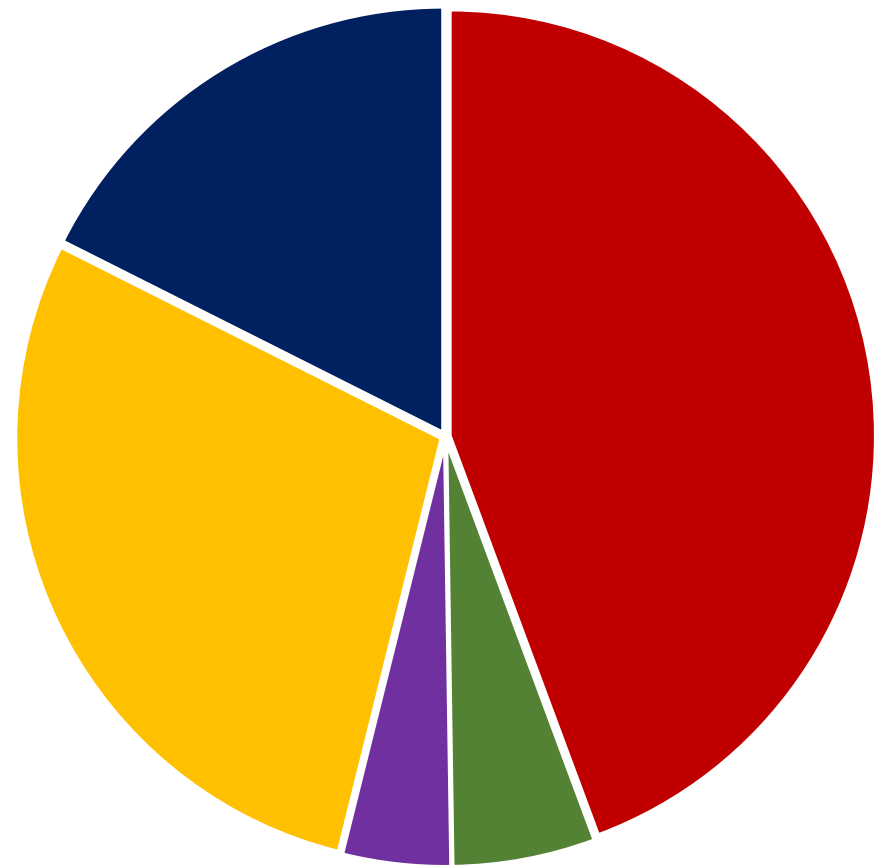


2022 Deaths by Facility Type



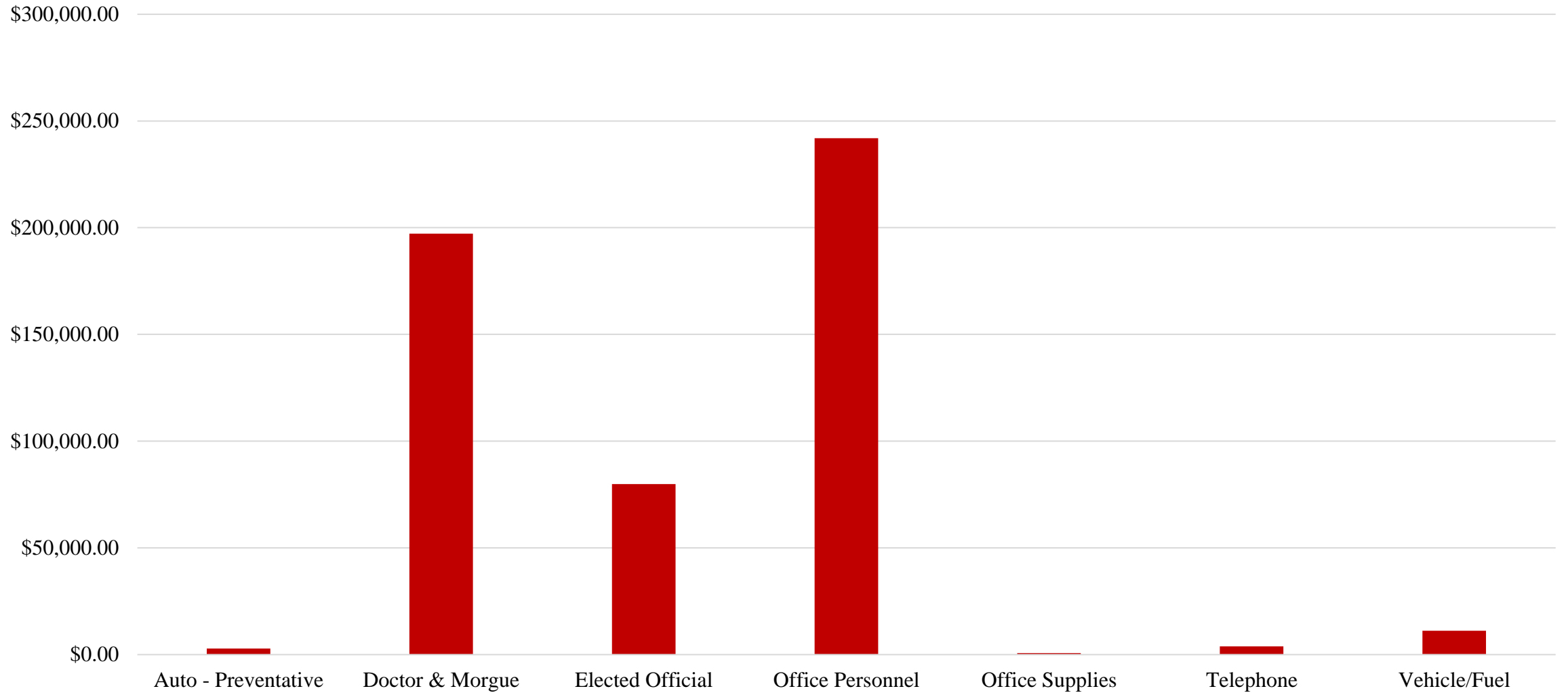

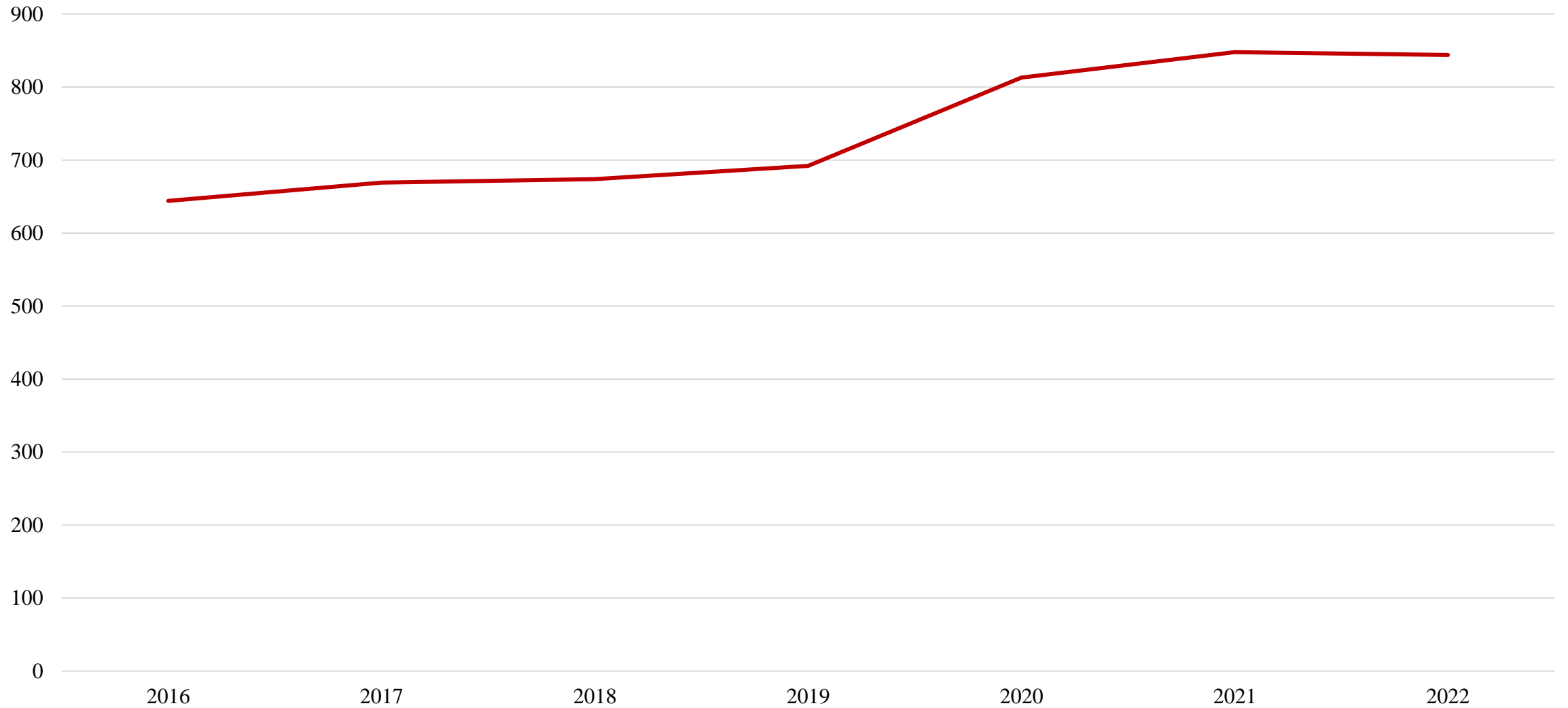

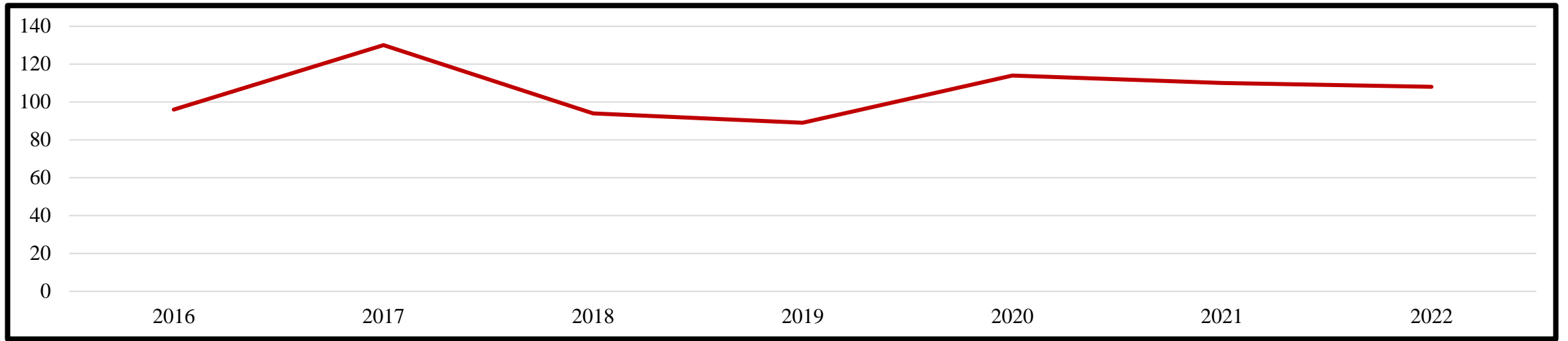

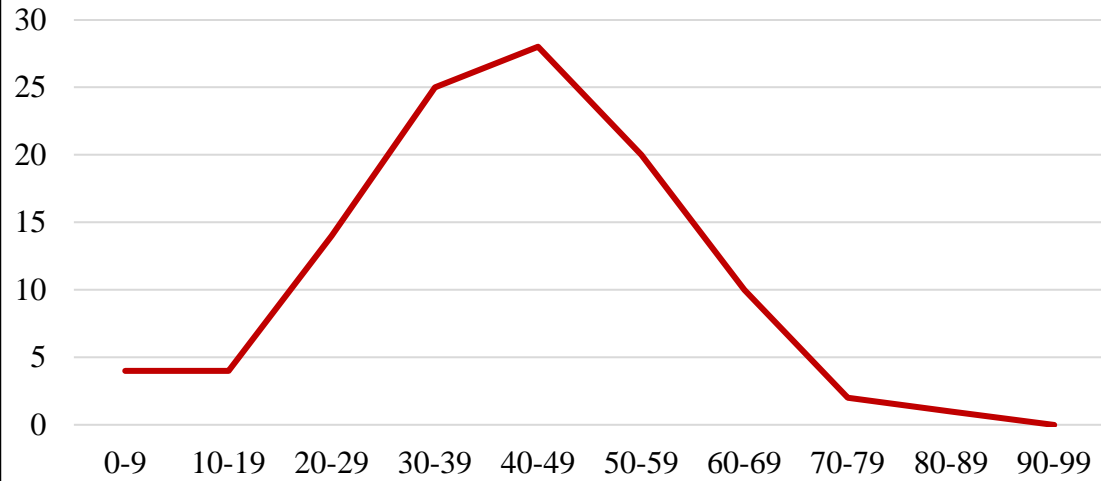

Autopsies by Year

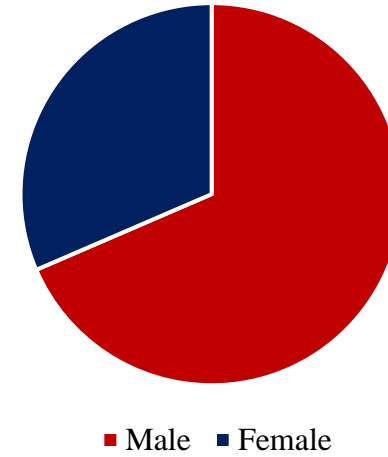

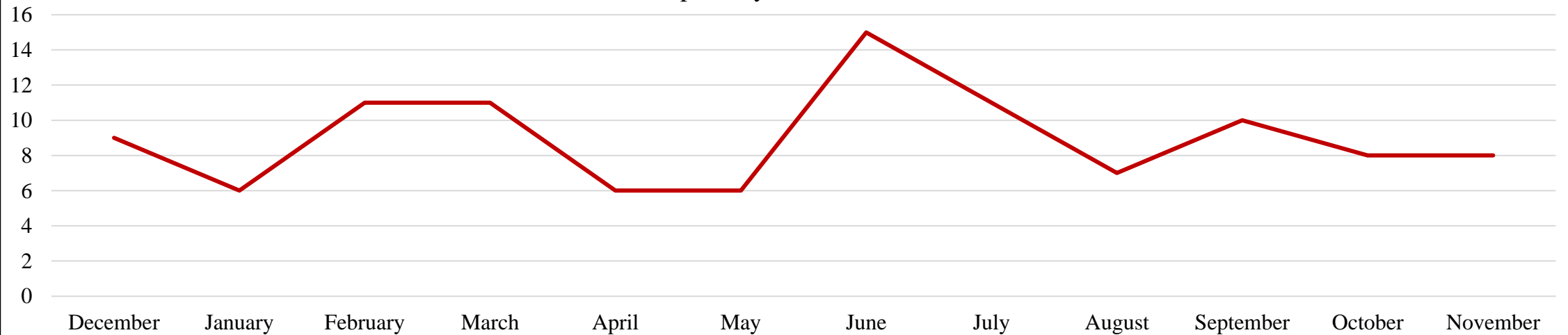
Autopsies by Age



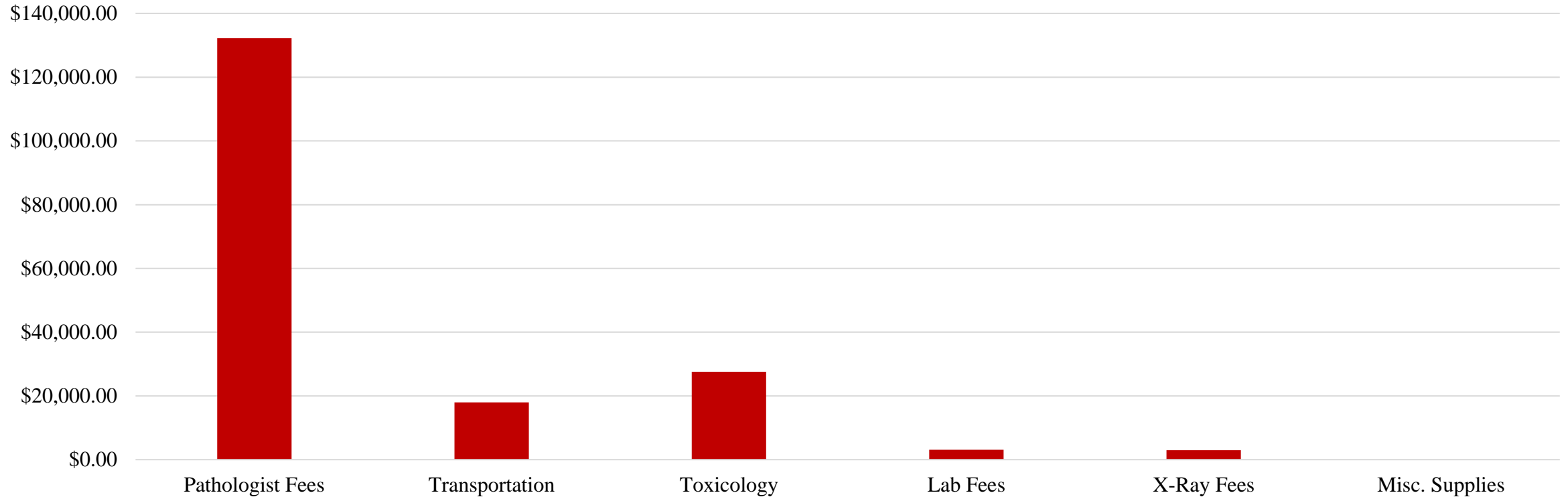
Autopsies by Gender

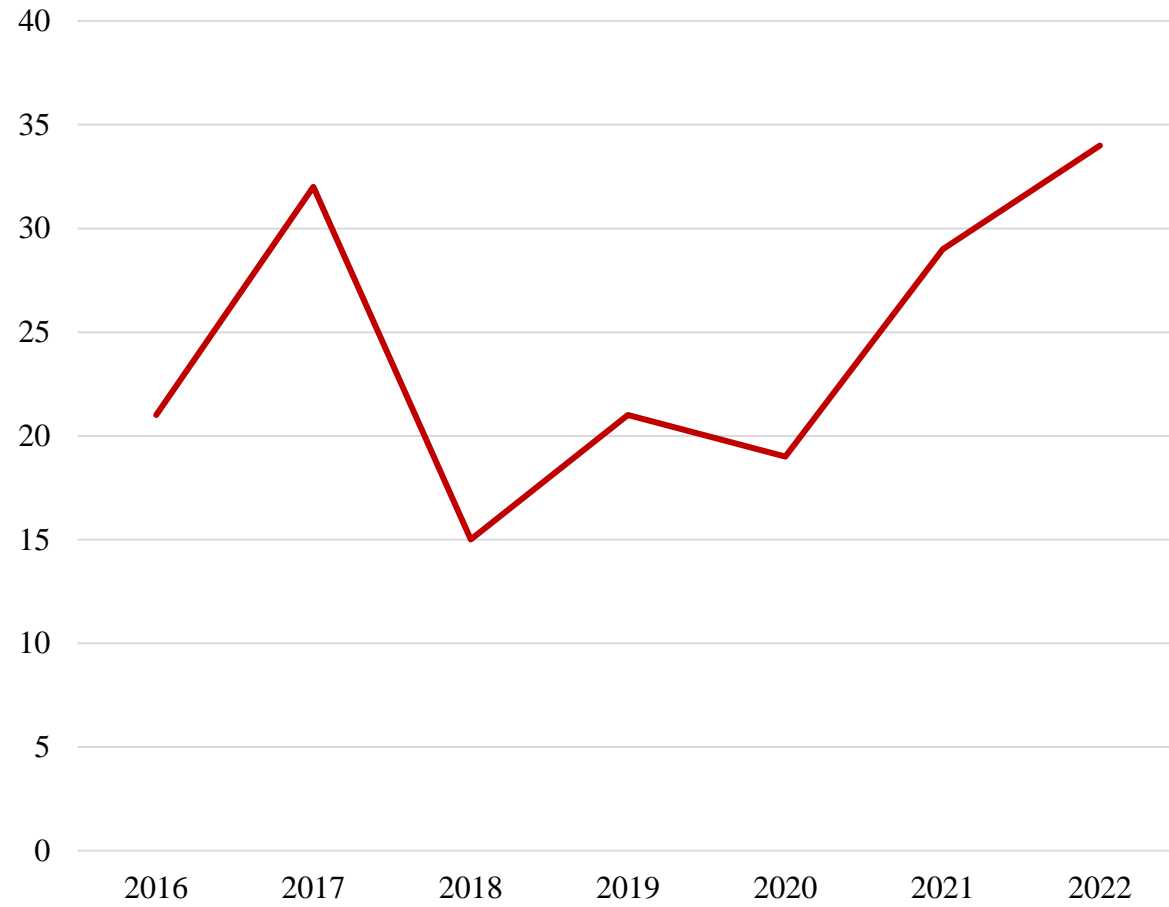
FY2022 Autopsy Expenditures



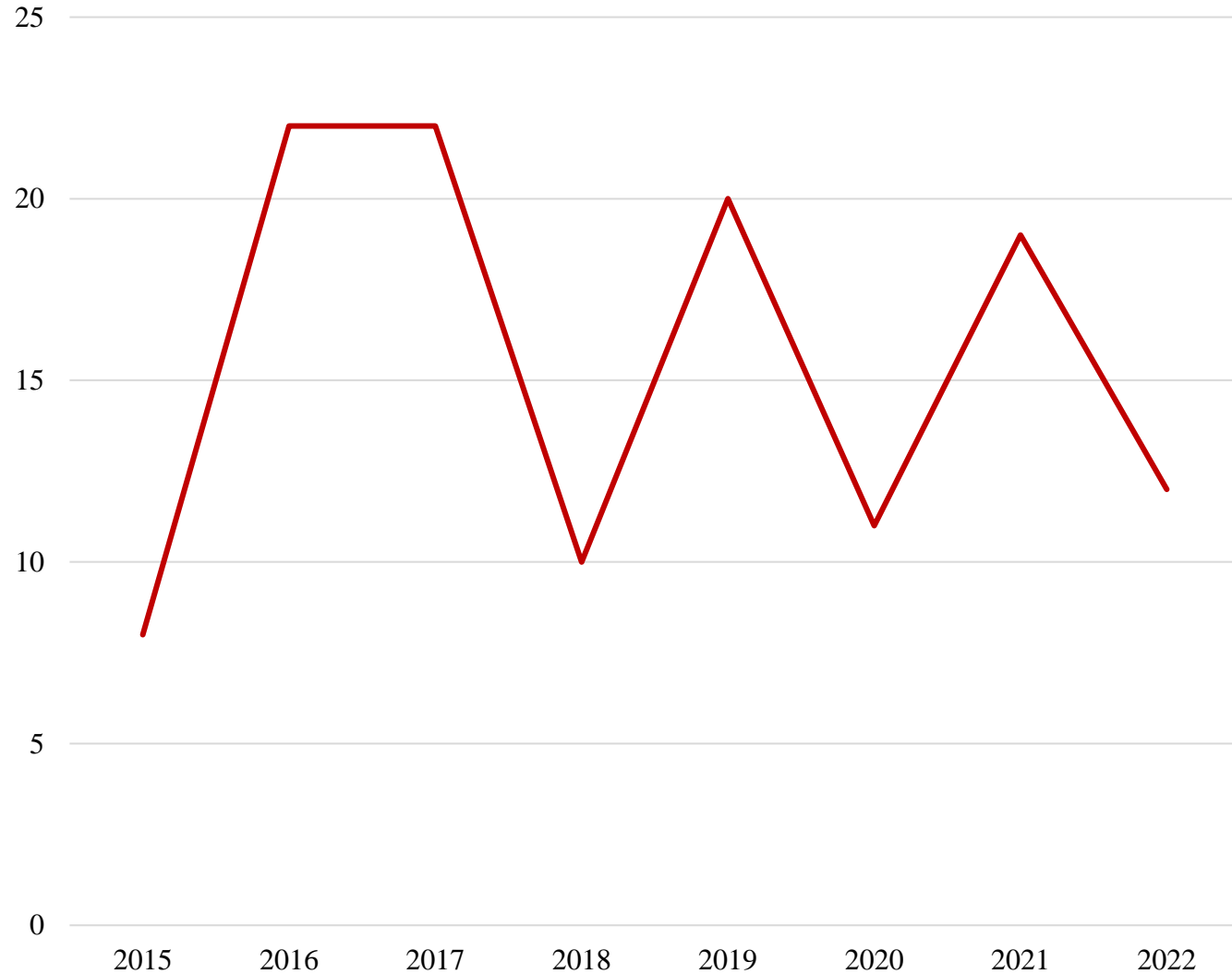

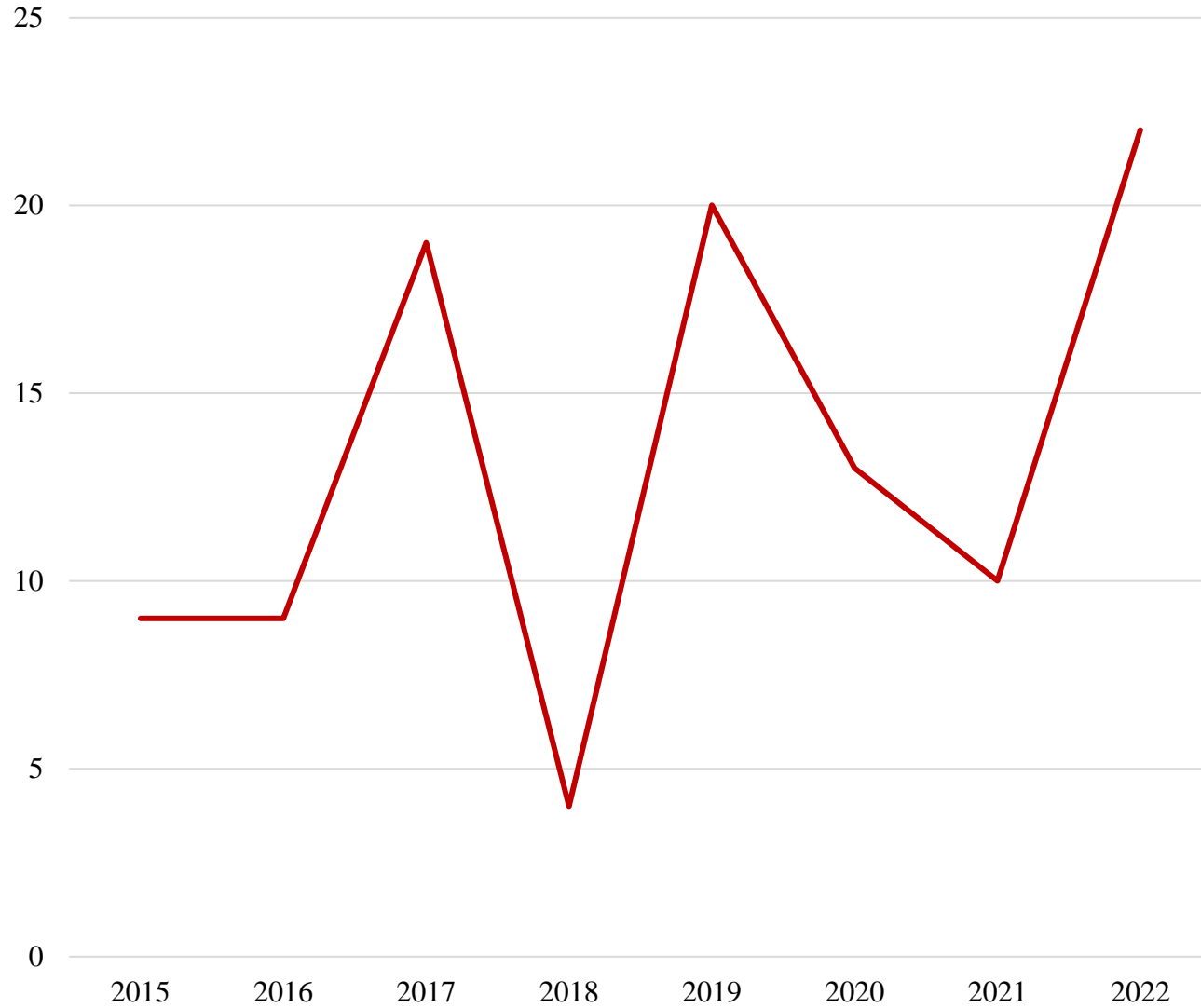


Motor Vehicle Fatalities



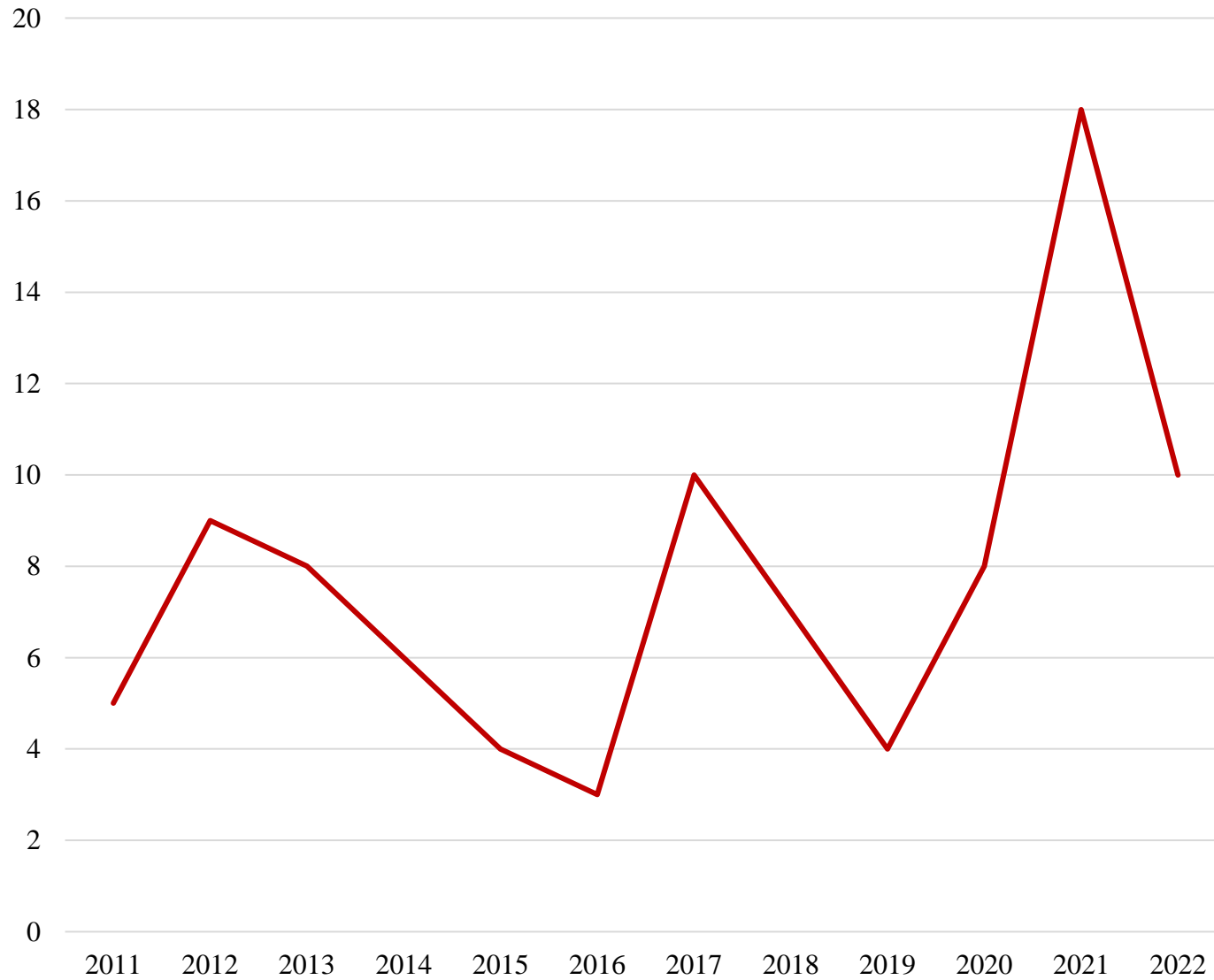

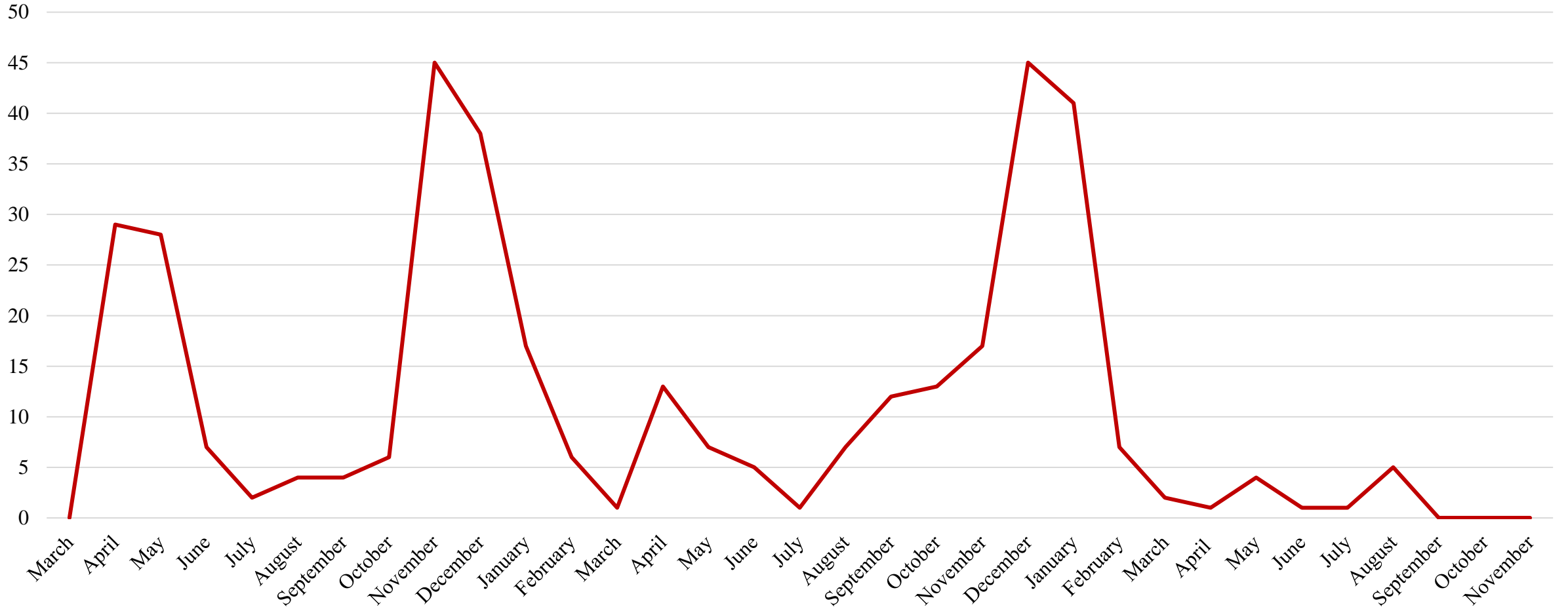

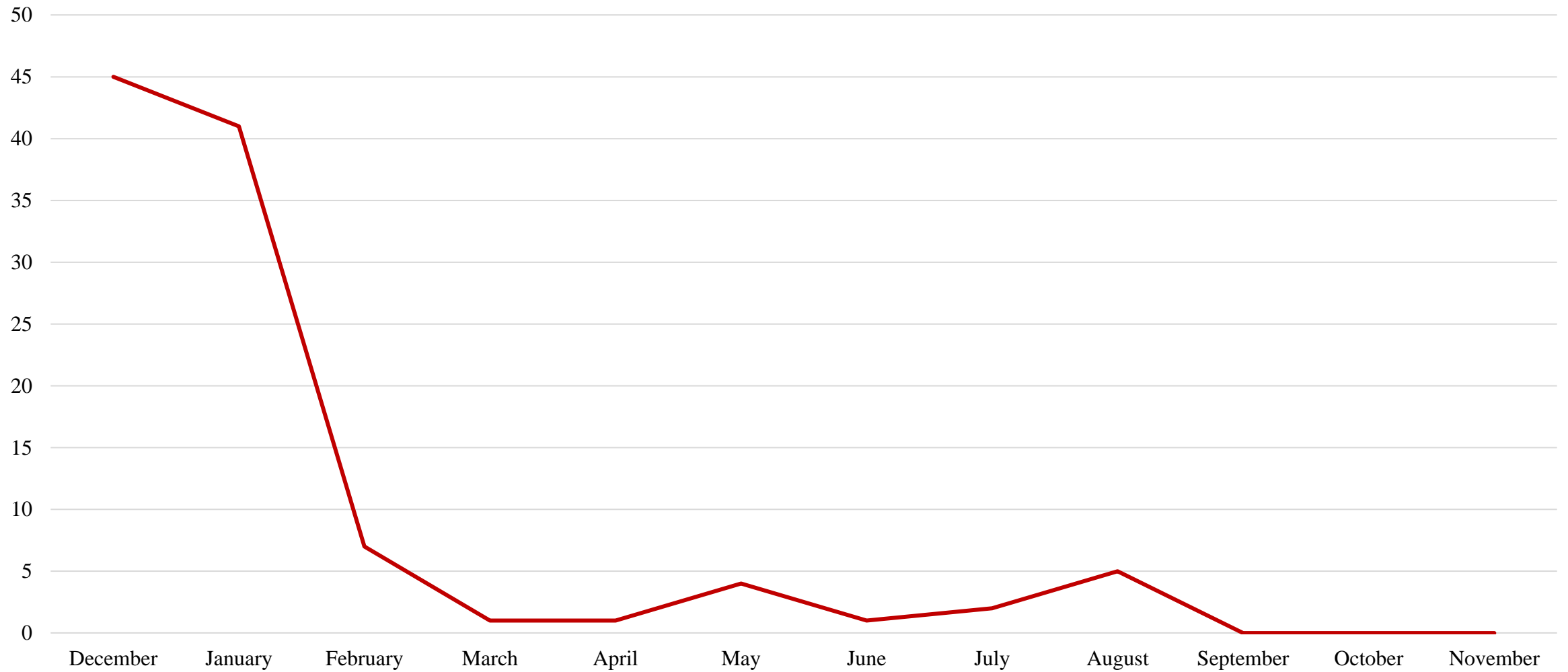

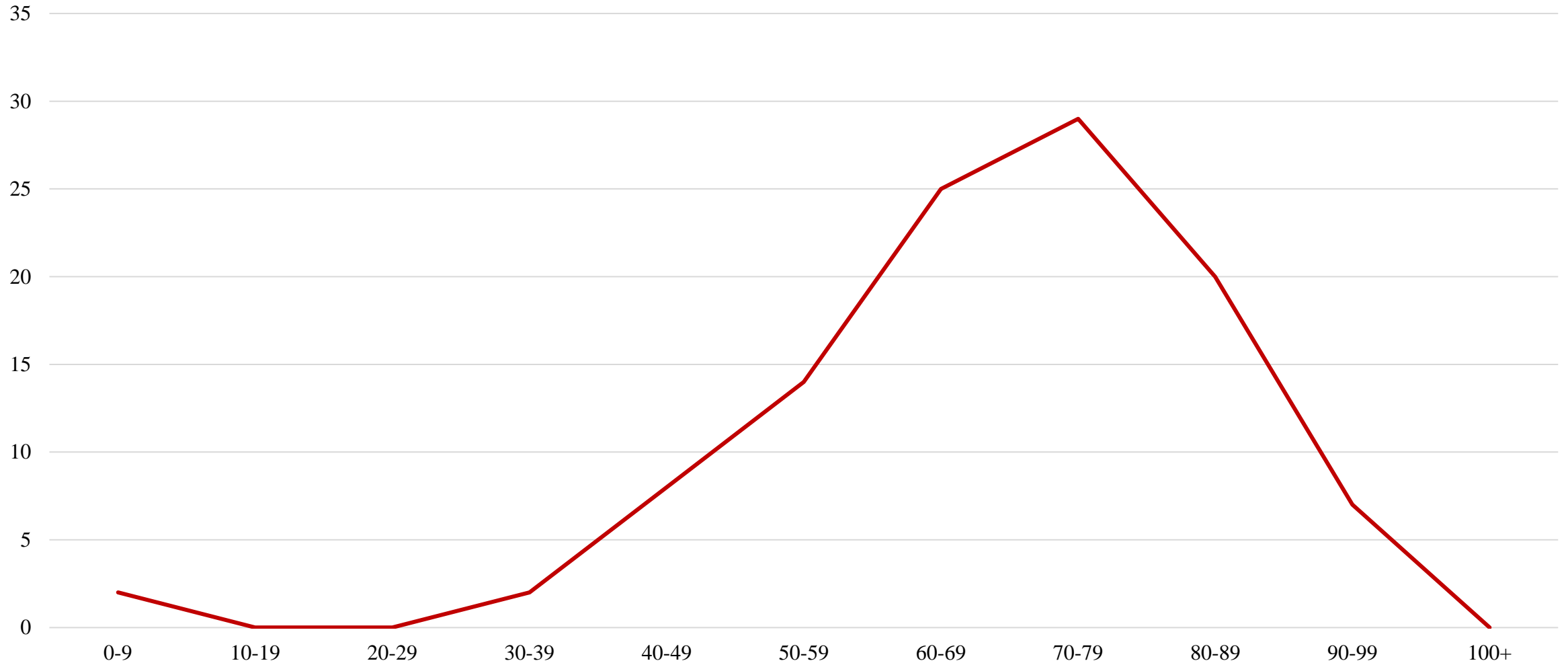

2022 COVID-19 Deaths by Month



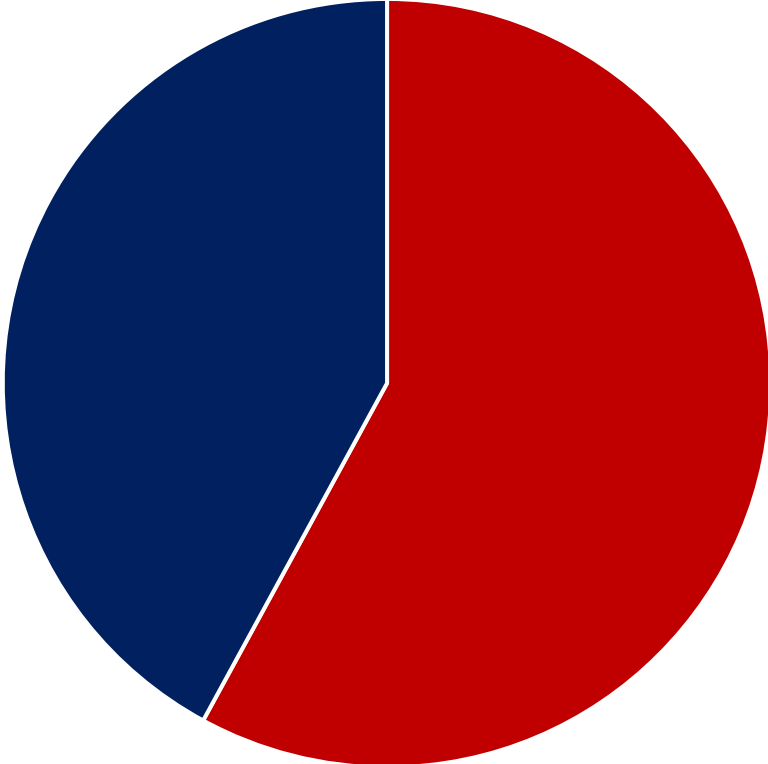

2022 COVID-19 Deaths by Age



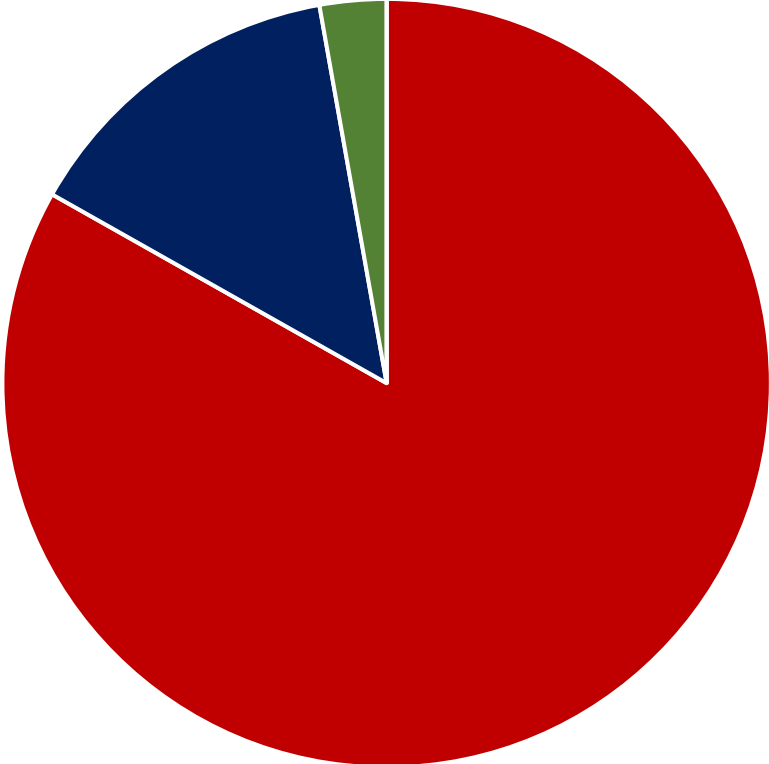
